Code Task Force Completes its Work Public Hearing on Zoning & Subdivision Changes Scheduled for August 23

Code Task Force Chairman, Mike Baden, reported to the Town Board that the group has completed its deliberations and recommendations for changes to the subdivision laws. The last set of revisions are being incorporated by the consultant, Tom Shepstone, who expects the final product to be completed within a few days. The final report will be sent to the Supervisor on or about August 8.

Baden reported that

the work is the result of 37 workshop meetings and 4 public meetings, and that every comment made by audience members has been reviewed and thoroughly considered before the committee produced its final recommendations and report. On behalf of the Town Board, Supervisor Duke thanked the committee for the momentous effort.

The Board has scheduled a Public Hearing for Thursday, August 23 at 7 p.m.

If the changes are adopted by the Town Board, the result will be to repeal and replace certain sections of Local Law #4. Sections to be repealed are Section 125 (Subdivision), Section 130 (Telecommunications), and Section 140 (Zoning). Also, the existing Zoning Map of the Town of Rochester would be repealed and replaced by a new Zoning Map of the Town of Rochester. The recommended changes to the building and subdivision codes will be posted on the Town website when received by the Supervisor. The proposed new Zoning Map has already been posted.

August 2 Town Board Meeting Highlights

- < The Board approved the bid from Don Oakley & Co. for \$17,900.00 to provide new roofing for the Community Center.
- < Following 8 interviews, the Board approved the hiring of Ruthann Rabuffo for the position of Assessor Aide. She is expected to assume her new position on August 13.
- < The Town is now being paid \$180 per ton for recycled metal. The Board recently approved a bid from T.A.M. Enterprises Roll-Off Services for disposal

- of all metal scrap. While revenues are already being realized, the amount expected over the year is yet to be projected.
- < Code Enforcement Officer, Jerry Davis, requested the Board to approve a more comprehensive and up-to-date Manufactured Home Permit Application. The Board will decide the matter following the August Audit meeting, during which Mr. Davis will provide more details of the proposed changes.
- < A July 2007 update to the TOR Veterans Database is in the works and posted on the Town web site.
